## Please Note:

- Forms must be complete (including signatures and payment) in order to be accepted for scheduling.
- All completed test request forms and fees must be received by the Figure Skating Club of Southern California Test Chairman at least **THREE WEEKS PRIOR TO THE TEST DATE REQUIRED**.
- Test request forms will be processed in the order received. Test candidates will be scheduled for the next available test session on or after the date requested. Sometimes, judges cannot be obtained and that necessitates rescheduling of tests.
- There will be **NO REFUNDS** for tests cancelled for injury without certification from a medical professional, to be received within 7 days of the test date.
- There are NO REFUNDS for contingent tests in a session that do not run because the initial test was not passed.
- Test schedule change requests (i.e. requests to be moved to a later date) will be considered a cancellation; a new test form, along with fees, must be re-submitted.
- Letters of permission for non-FSCSC members are required and must be attached to this form.
- Test Session dates, times, and schedules, will be posted on the FSC of Southern California bulletin board at Toyota Sports Center and online (<a href="www.fscsocal.org">www.fscsocal.org</a>) approximately one week before each test.
- Late test requests (less than seven days before the session desired), if accepted, will require a \$25 late processing fee.
